CONDITIONS

GISBORNE GOLF CLUB LADIES OPEN CHALLENGE BOWL

1. The Competition shall be played in accordance with the Rules of Golf as adopted by The Royal and Ancient Club of St. Andrew's Scotland, together with Local Rules of the Gisborne Golf Club Inc. If a dispute arises on any point, it shall be decided by the Match Committee in charge of the Competition whose decision shall be final.
2. The event is open to all ladies who hold a current Australian Handicap.
3. Competitors will be drawn to play in such manner as the Match Committee may arrange, and the Match Committee or such person as they may authorise shall have power to select a partner for any competitor whose partner is not at the tee when called upon at the time appointed to start.
4. The Match Committee to make all arrangements, and to have full power to alter or make any variation in the conditions of the program should they deem it desirable.
5. The Match Committee or such person as the Match Committee authorises, may, in the event of bad weather or for any other reason, either shorten the contest or fix another day.
6. In the event of a tie in the CHALLENGE BOWL, the winner shall be determined by a count back using the three team members' scores over the last 9, 6, 3, holes. If still tied, then hole by hole from the 18th. In the event of a tie or ties in the individual event, the winners shall be decided on a count back using the same method.
7. The Match Committee shall have the rights to refuse entry of any person, without being required to give any reason for such refusal.
8. The Match Committee shall have the power to limit the number of entries that will be received, and to alter the time fixed for starting.
9. The attention of all entrants is directed to the necessity of accuracy in her entry form, and any entrant who is misrepresented renders herself liable to disqualification.
10. The wearing of slacks and jeans of respectable nature are permitted on course.
11. Golf Victoria Standard Conditions of entry including Accidents, Drugs and Personal Risk apply.
12. The Club returning the highest aggregate points score shall hold the Bowl for one year, and is **responsible for the engraving and return of the Bowl prior to the 2020 event.**
13. Players consent to Gisborne Golf Club Inc entering personal details contained on this entry form into a database that will be used for the administration of the event. Players also consent to personal details being used by GGC Inc for future marketing and promotional purposes.
