## CONDITIONS

1. The Competition shall be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Club of St. Andrew's, Scotland, together with the local rules of the Kilmore Golf Club Inc. If a dispute arises on any point, it shall be decided by the Match Committee in charge of the Competition, whose decision shall be final. Provided, however, that any player may request the Secretary of her Club to ask the Executive Committee of G.V. for an interpretation of any rule of the procedure in any particular case.
  2. In every event competitors will be drawn against each other for the day in such a manner as the Match Committee may arrange. However, the Match Committee, or such person as they may authorise, shall have the power to select a partner for any competitor whose partner is not on the first tee when called at the time appointed to start.
  3. The Match Committee to make all arrangements, and to have full power to alter or make any variation in the Conditions of the Program should they deem it desirable.
  4. The Match Committee or such person as the Match Committee may authorise, in the event of bad weather or for any other reason, either shorten the contest or fix another day.
  5. In the event of a tie in the CHALLENGE BOWL, the winner shall be determined by a count back using the three team members' scores over the last 9, 6, 3 holes. If still tied, then hole by hole from the 18th. In the event of a tie or ties in an individual event the winner/s shall be decided by the same method.
  6. The events are open to all ladies of Clubs registered with the G.V. for handicap purposes.
  7. The Ladies Committee of Kilmore Golf Club Inc. shall have the right to refuse entry to any person without being required to give any reason for such refusal.
  8. The Match Committee shall have the power to limit the number of entries that will be received in any event, and to alter the time fixed for starting any event as indicated in this program.
  9. The Match Committee, or such person as it may authorise so to do, may, if thought fit, permit any competitor who is not ready to start at her appointed time, to start at a later hour.
  10. The attention of all entrants is directed to the necessity of complete accuracy in her entry form, and any entrant who is misrepresented renders herself liable to disqualification.
  11. Professionals are not permitted to caddy.
  12. GV standard conditions of entry including Accidents, Drugs and Personal Risk apply.
