Women's 4BBB Aggregate Teams Event (18 holes)

Conditions of Entry:

1. All competitors must be a financial playing member of the Club they are representing and have a current Golf Australia Handicap.
2. Entry forms, accompanied by entrance fees, must be in the hands of Gardiners Run Golf Course by 3rd October.
3. Competition shall be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Club of St Andrew's Scotland, together with such Local Rules as may be currently in force at Gardiners Run Golf Club. If a dispute arises on any point, it shall be decided by the Match Committee of the Competition whose decision shall be final. Provided however that if the Match Committee is in doubt it shall have the right to refer any such dispute to Golf Victoria.
4. The Match Committee shall have the entire management of the event.
5. The Match Committee will make all arrangements and will have full power to alter or make any variations in the conditions should they deem it advisable. In the event of bad weather or for any other reason the Match Committee may either shorten the contest or fix another day.
6. The Match Committee shall have the power to limit the number of entries which will be received in any event, and to alter the time fixed for starting as indicated in the program.
7. Ties shall be decided by count back as recommended by Golf Australia.
8. The Match Committee shall have the right to refuse the entry of any person without being required to give any reason for such refusal.
9. The attention of all entrants is directed to the necessity of accuracy in the entry form, and any entrant who is misrepresented renders themselves liable to disqualification.
10. The maximum handicap allowed for women shall be 45.
